Work opportunity for International Medical Graduates

Hence, International Medical Graduates seek work opportunities. which could help them earn money and gain clinical experience at the same time. This article is a consolidation of contents from more than ten websites. The conclusion is that-there are health care job opportunities for ECFMG-certified (the Educational Commission for Foreign Medical Graduates -certified) international medical graduates and it would be easier for non-visarequiring candidates. An entry-level job opportunity may lead to another clinical job opportunity during which the candidate could build on strong clinical background in the United States of America and be financially sufficient. Persistence is the key to success.

A Master of public health (MPH) degree can give you a career in public health in addition to training in research, connections with eminent faculty, increase the probability to get a few first author publications. Also, if you major in Epidemiology or Biostatistics, you are eligible for a STEM extension on your visa. There are state medical board job opportunities for International medical graduates. These may require certain qualifying criteria including citizenship or housing in the state.5 Few are listed below:

Highlights of the Graduate registered physician act of Arkansas state medical board includes the applicant's year of graduation to be within past two years and applicant to be a resident of the state or US national. Similar opportunities are also available in Arizona, Kansas, Missouri, and Utah.7 Virginia is considering one. Limited permits in New York allows a qualifying international medical graduate to practice under a New York registered physician at a general hospital, nursing home, State-operated psychiatric, developmental or alcohol treatment center, or nonprofit institution for the treatment of the chronically ill.

Residency application is a stressful journey. Above average United Stated Medical Licensing Examination (USMLE) scores, ample clinical experience in the United States, and a captivating resume within a specific time –all are essential to get matched. International medical graduates with visa or without Green card/citizenship face challenging situations accordingly. Many factors become determinants of a successful residency journey for International Medical Graduates. For me, the year of graduation has been a crucial factor.1

Being an international medical graduate with an older year of graduation had put me in a great deal of financial burden while applying through different residency match seasons. I worked as a clinical assistant which provided me with clinical experience and financial support at the same time. I would like to discuss some of the job opportunities available hoping it would be a helping hand to some of the International Medical Graduates.2

Persistence is the key. There are renowned hospitals and healthcare agencies in the United States of America offering job opportunities for ECFMG-certified International Medical Graduate candidates. Research intern /research fellow (unpaid) position at John H. Stroger, Jr. Hospital of Cook County Illinois, preresidency fellowship opportunities available in various institutions including the New Mexico university, University of Utah9, University of Wisconsin Madison, are few among the golden opportunities to gain valuable clinical experience in United States.10 The table below shows some other job opportunities for International Medical Graduates:

Most International Medical Graduates go into research. Sometimes, the number of publications becomes a deciding factor in the number of residency interview invites; hence the increased chances of getting matched. Many institutions allow ECFMG-certified International Medical Graduates to be post-doc fellows. Research experiences and prior publications certainly increase the chance of getting accepted as post doc fellows. Many research internship opportunities are also available. Be a published author program by California Institute of behavioral Neurosciences &Psychology, The Introduction to the Principles and Practice of Clinical Research certificate course by National Institutes of Health (NIH), -are few among the research courses available to help International medical graduates gain research experience. Certain universities offer degrees in research; e.g.: Master of Science in Health Sciences (MSHS) in clinical and translational research program by the George Washington university. Certainly, professional courses require one to two years of education and fees -but it matters according to your goals. One can attain an online degree while working in research or other health care fields which will certainly boost your clinical acumen.
